Online applications in prescribed form are invited for admission to the Ph. D. program in Assam University, Silchar H. Q. and Diphu Campus for the academic session 2022-23. For details candidates may visit university website **www.aus.ac.in**.

For details of vacancy positions (Proposed Intake) candidates are advised to visit profile of the respective Academic Department published in the Admission Prospectus. Eligibility Criteria:

The following shall be the eligibility criteria for admission to Ph.D program under Assam University:

- (a) Candidates for admission to the Ph.D. programme shall have a Master's degree or a professional degree declared equivalent to the Master's degree with at least 55% marks in aggregate, or its equivalent grade or an equivalent degree from a foreign educational institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized, by an authority established, recognised or incorporated under a law in its home country or any other statutory authority in that country empowered for assessing, accrediting or assuring quality and standards of educational institutions.
- (b) A relaxation of 5% of marks, from 55% to 50% or an equivalent relaxation of grade may be allowed for those belonging to SC/ST/OBC (Non-creamy layer)/ differently able and other categories of candidates as per the decision of Government of India (GoI) from time to time, or those who had obtained their Master's degree prior to 19th September, 1991. The eligibility marks of 55% (or an equivalent grade in a point scale) and the relaxation of 5% to the categories mentioned above are permissible based only on the qualifying marks without including the grace marks.
- (c) Candidates shall be eligible to proceed to do research work leading to Ph.D degree in an integrated program in the university, if
 - The candidates who have cleared an M.Phil. Course work in the same subject with at least 55 % marks in aggregate or its equivalent grade 'B' from the university as per AUS Ordinance on M.Phil and Ph.D degrees in force.
 OR
 - (ii) The candidate has already completed the course work in M.Phil. in the same subject as per AUS Ordinance on M.Phil and Ph.D degrees in force with at least 55% marks in aggregate or its equivalent grade in the AUS grading scale and successfully completed the M.Phil. Degree in the same subject.

A relaxation of 5% of marks, from 55% to 50% or an equivalent relaxation of grade may be allowed for those belonging to SC/ST/OBC (Non-creamy layer)/ differently abled and other categories of candidates as per the decision of Government of India (GoI) from time to time.

- (d) Candidates seeking admission against OBC (Non-creamy layer) quota must submit valid Income Certificate from the appropriate authority in support of his/her belonging to OBC (NCL) category.
- (e) A student of Assam University, who's M.Phil. Dissertation has been evaluated and the viva voce is pending, may be admitted to the Ph.D. programme of the University. A certificate of completion of evaluation of dissertation obtained from COE should be produced before the DRC by the candidate at the time of personal interview.
- (f) Candidates possessing a Degree considered equivalent to the M. Phil. Degree of an Indian Institution, from a Foreign Educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established, recognized or incorporated by law in its home country or any other statutory authority in that country empowered for assessing, accrediting or assuring quality and standards of educational institutions, shall be eligible for admission to Ph.D. programme.

How to Apply:-

Candidates may apply online on payment of Rs. 1000.00 (for General and OBC students), Rs. 900.00 (for OBC (NCL)/ EWS) and Rs. 800.00 (for SC/ST/PWD students) through online as application fee. The web link for the purpose shall be <u>https://www.ausexamination.ac.in/admission</u> and shall remain active on the university admission portal from 29th September, 2022 till 27th October, 2022.

Interested candidate may apply up to a maximum of two courses only for Ph. D. Programme offered by allied departments. However, separate application should be submitted for each course with requisite application fees.
