

## ASSAM UNIVERSITY, SILCHAR EXAMINATION DEPARTMENT NOTICE

This is for information of all concerned that Assam University is going to conduct Special Course Work Examinations under old syllabus (without RPE) along with the regular Course Work Examination, 2020 and 2021.

The scholars admitted in the Ph.D. programme of Assam University 2017 onwards are eligible to appear in these special Course Work Examinations (either in Course Work Examination 2020 to be held in May 2021 online or Course Work Examination 2021 to be notified in due course of time). If -

- ➤ they are holding M.Phil. degree from Assam University with 4 papers in Course Work with less than 55% marks in aggregate and pursuing Ph.D. programme need to appear all four papers (501,502, 503 and 504) of Course Work afresh.
- they are already holding M.Phil. degree from a dept. of Assam University but pursuing Ph.D. programme in another Department under the same School need to appear either of the paper 502, 503 and 504 or all four papers of Course Work (to be decided by RAC concerned). Scholars already holding M.Phil. degree from Assam University and pursuing Ph.D. programme in another Department under a different School of study need to appear in all four papers (501,502, 503 and 504) of the Course Work.
- ➤ they are holding M.Phil. degree from Assam University with Course Work from a different university without proper approval from the competent authority and pursuing Ph.D. programme also need to appear in all four papers (501,502, 503 and 504) of the Course Work.

It is further informed that those scholars who are covered under special course work examinations shall be allowed to submit their thesis for evaluation on completion of all required formalities for submission of thesis. However, her/his result shall be kept in abeyance until s/he qualifies the Course Work examination with a minimum of 55% marks in aggregate. Scholars must qualify special course work examination within the stipulated time, failing which their admission in Ph.D. programme will stand cancelled.

Submission of examination forms for the ensuing Course Work (Special) Examination, 2021 should be made as per the following guidelines:

- Scholars shall deposit examination fees to bank account No.: 20050110032152, Bank: UCO , Branch : Assam University, IFSC- UCBA0002005 through online mode.
  - Last date of payment of requisite fee @ Rs.1375/- and submission of duly filled in examination form by Scholars : 15<sup>th</sup> May 2021.
- 2. Duly filled in examination form (form to be downloaded from the university examination website: <a href="mailto:ausexamination.ac.in">ausexamination.ac.in</a>) along with details of payment of fees and other supporting documents **compiled in a single pdf file** should be mailed to the respective Head of Department within the stipulated time for onward transmission to examination department.

3. The concerned department shall take print out of examination forms submitted by the students along with attachments and forward the same to the undersigned after completion of all formalities at their end by 17<sup>th</sup> May 2021. In case of any unforeseen emergency, the HOD shall put all the pdf file (consisting of exam. Form, fee payment document and supporting documents) received from the applicants in a zip folder and mail it to COE at <a href="mailto:au.examination@gmail.com">au.examination@gmail.com</a>.

The HODs are requested to send the list of such special examinees to the concern Dean by 17<sup>th</sup> May 2021 without fail. If there is no such candidate, the matter also needs to be informed by 17<sup>th</sup> May 2021 to the Dean concerned with a copy to the undersigned.
